Year-Round Child Care

(After School & Summer Day Camp)

SIGN UP AND SAVE!

Register once and you are automatically signed up for 2011/2012 after school and 2012 Summer Day Camp! Both programs are offered at a reduced rate, added together and divided by 12 months for your monthly fee. On average your family will save per child per year \$781 for Y based and \$385 for School Based. Become a family member of the YMCA and save even more! \$1315 for Y Based and \$505 for

School Based. Registration for Year-Round Child Care is from August 1 - September 30 only. All payments are made by credit card or bank draft at the first of each month.

YMCA Based Child Care

We also offer after school child care for all other MISD schools and some private schools via YMCA transportation. Children are transported to the YMCA for their activities and parents pick children up at the Midland YMCA.

Fees: Registration Fee \$25
YMCA Family Member \$180/mo
Program Participant \$270/mo

Activities for Both Programs

The YMCA child care program is curriculum-based with activities that include homework assistance, crafts, character development, holiday parties, games, and snacks. Additional activities offered at YMCA Based Child Care: Music, Youth fitness room equipped with Dance Revolution and Nintendo Wii. Youth fitness classes include (Kid Zumba, Yoga.)

Registration and Payments

All registration forms must be completed and fees paid in person to enroll in the program. These fees consist of an initial down payment (to be calculated during sign up) and a one time registration fee of \$25. Fees must be paid by automatic bank draft or credit card deduction on a monthly or bi-monthly payment plan. Your payment plan is continuous until the end of the child care program. In the event you want to discontinue child care service, you are required to provide the YMCA with a 30 day written notice to stop the bank draft/credit card withdrawal. No Refunds

2012 SUMMER DAY CAMP

All payments must be made by credit card or bank draft. The fee is the same regardless of your child's attendance. No refunds. Registration Fee: \$25
YMCA Family Members \$320/mo or \$80/wk
YMCA Program Participant \$480/mo or \$120/wk

YMCA Staff

All staff is screened and trained through the following process:

- Completion and review of a criminal background check conducted by the YMCA and the TDFPS.
- Drug screening
- Attend and complete an eight hour pre-service child care training before working
- Successful completion of 15 required training hours by employees throughout the year
- Employees must obtain CPR and Basic First Aid certification
- Child Abuse Prevention Training

Staff persons operating YMCA vehicles must:

- Complete a driver safety training course
- Pass a review of his or her driving history
- Maintain the appropriate driver's license
- Must be at least 25 years of age

Other Helpful Information

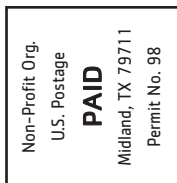
- All children must have a completed registration form and immunization record on file at their school
- Program runs 3:20 pm - 6:00 pm, a late fee of \$1 per minute will be charged beginning at 6:05 p.m. and must be paid before child returns to program

Sign In/Sign Out

Parents and/or those authorized to pick up child(ren) as noted on the registration form must sign the child(ren) out each day. Authorized person will be asked for identification and should be instructed to have proper photo ID available at the time of pickup. If an unauthorized person comes to pick up a child(ren), the parent will be notified.
